Subject: -Grant of temporary affiliation for introduction of B.Sc Paramedical Degree Programmes from the academic session 2020-21 at GMC, Baramulla.

Sir,

Pursuant to the report of the Inspection Committee dated 22.08.2020 and in anticipation of the approval of the competent body, the Vice Chancellor has authorized the grant of temporary affiliation in favour of Govt. Medical College, Baramulla for introduction of the following B.Sc Paramedical Degree Programmes from the academic session 2020-21,

1.	B.Sc Medical Lab Technology	20
2.	B.Sc Operation Theatre Technology	20
3.	B.Sc Renal Dialysis	20
4.	B.Sc Radiography	10
5.	B.Sc Anesthesia Technology	10

The temporary affiliation is subject to the fulfillment of the following conditions, otherwise the University is vested with the authority to withdraw the affiliation forthwith under relevant sections of Kashmir and Jammu Universities Act, 1969 and other relevant statutes:-

1. Seek the recruitment of the necessary Faculty (full time) separately for the above Programmes of Paramedical Sciences as per J&K Paramedical Council norms for the newly introduced programmes before the commencement of the classwork;
2. ensure the upgradation of all the existing training labs; procure and install the necessary equipment in the labs as per the prescribed norms of regulatory/statutory bodies before the commencement of the classwork;
3. seek the approval from the competent authorities for change of nomenclature of one programme from B.Sc Radiography to B.Sc Radiodiagnosis and Imaging Technology;
4. develop and create a new oxygen plant for continued oxygen supply with workable oxygen pressures, oxygen concentrators and oxygen banks to give uninterrupted supply to operation theatres and intensive care units;
5. develop separate audio video lecture halls cum demonstration labs with a museum for the new programmes;
6. develop simulation labs pertaining to various procedures and designated resuscitation rooms in emergency areas;
7. develop a well maintained library with at least 10, 000 books, or 100 books of different titles on each subject, whichever is more, of the proposed programme to include both text books and reference books, along with a book bank facility for students belonging to the Schedule Castes, Schedule Tribes/Minorities and such other sections as may be specified by the UGC/MCI from time to time;



8. the college library should subscribe to atleast one journal (hard copy) in each of the following subjects: - Anatomy, Physiology, Biochemistry, Pathology, Pharmacology, Radiography, Physiotherapy, Cardiology, Medicine. American Journal of Surgery, American Journal of Physiology, American Journal of Pathology, Indian Journal of Medical Research, J-clinical Investigation, etc;
9. the college and its associated hospital should be connected through internet with reputed health institutes to get benefit of E-medicine and latest medical and surgical techniques available in those institutes;
10. renovate/upgrade the existing bath/wash rooms for male & female separately to cater to staff and student requirements;
11. develop and create a computer lab with broadband facility having 50 systems and 4 printers;
12. develop playground for outdoor games and basic infrastructure for indoor games for both students and the staff;
13. seek appointment of a Physical Director/PTI to take care of sports related activities in the College;
14. follow the J&K Paramedical Council guidelines as well as the mandate of the affiliating University in letter and spirit for effective functioning of the College;
15. submit compliance report of the present inspection within 6 months to the Dean College Development Council, University of Kashmir;
16. pay the affiliation fee as prescribed by the affiliating University.
