Subject:- Grant of temporary affiliation for running 5 year MBBS programme from the session 2019-20 with an approved intake of 100 seats.

Sir,

Pursuant to the report of the Inspection Committee dated Nov. 26, 2019 and in anticipation of the approval of the competent body, the Vice Chancellor has authorized the:

Grant of temporary affiliation for running 5 year MBBS Programme with an approved intake of 100 seats from the academic session 2019-2020. subject to the fulfillment of the following conditions, failing which the University shall have authority to withdraw the same under relevant law, statutes & rules: -

1. Seek the completion of the construction work of the new College building, hostels, ward block, academic block, residential quarters, etc by or before the end of 2020;
2. seek further recruitment of the qualified persons as teaching faculty immediately as per the prescribed norms of the MCI/Affiliating University after following proper selection process, especially the recruitment of the following should be taken up within 6 months:
 - a) One Professor in each Departments of Physiology, Biochemistry, Medicine, Dermatology, Ophthalmology, Pediatrician, Forensic Medicine, Radiology/Oncology, Microbiology, Psychiatry, Radiotherapy and Gynecology & Obst.;
 - b) One Associate Professor in each Departments of Gynecology & Obst., Pharmacology, Forensic Medicine, Radiology/Oncology, Microbiology, Chest Medicine, Psychiatry and Radiotherapy;
 - c) One Assistant Professor in each Departments of Anatomy, Radiology/oncology, Biochemistry and Medicine;
 - d) Five Sr. Residents in Medicine and Surgery, two Sr. Residents in each Departments of Gynecology, Radiology, Radiotherapy, one Sr. Resident in Ophthalmology, Pediatrics, Anesthesiology, Psychiatry, Orthopedics and Dermatology;
 - e) Three Demonstrators/Tutors in Physiology, Biochemistry, one Demonstrator/Tutor in each Departments of Pharmacology and Microbiology;
3. create additional patient bed capacity of 250 to make the total capacity of hospital upto 550 within 2 years and make the total capacity as 750 beds by the end of 5th year;
4. immediately enrich the college library with at least 10, 000 books, or 100 books of different titles on each subject, whichever is more, of the proposed programme to include both text books and reference books, along with a book bank facility for students belonging to the Schedule Castes, Schedule Tribes/Minorities and such other sections as may be specified by the UGC/MCI from time to time;
5. the college library should subscribe to atleast one journal (hard copy) in each subjects: - Anatomy, Physiology, Biochemistry, Pathology, Medicine, Surgery, etc. Besides, the library should keep available E-journals such as American journal of Medicine, American Journal of Surgery, American Journal of Physiology, American Journal of Pathology, Indian Journal of Medical Research, J-clinical Investigation, etc;
6. develop the Histology lab and practical labs of pre & para-clinical departments with autonsv and



7. the college and its associated hospital should be connected through internet with reputed health institutes to get benefit of E-medicine and latest medical and surgical techniques available in those institutes;
8. develop and create animal research house, Gas Plant(Manifold),computer lab. installed with necessary software needed for medical education with atleast 50 systems having broadband facility and 4 printers;
9. provide the hostel facility separately for boys and girls with recreational facilities;
10. develop the available spacious accommodation for outdoor and indoor sports activities for the students like playground, Gymnasium, with one Physical training instructor having appropriate professional qualification;
11. procure and install MRI plant, CT Scan, CTG Machines, Portable USG Machines, NICU facility with Ventilators. ICU facility needs to be augmented at an earliest which would help to ensure proper diagnosis and hence better patient care. Also install the relevant latest medical equipment as per MCI norms in other labs wherever required;
12. develop and create a Museum and equip the same with fiber optic bodies, skeletons, relevant models, etc;
13. arrange and develop adequate washroom/toilet facilities Gender-wise, for the staff/students in the college and for patients in the hospital;
14. develop and create a website with all the necessary information as per the prescribed norms;
15. submit compliance report (within 6 months) with regard to the fulfillment of conditions, as laid down by the MCI during their inspection;
16. submit compliance report of the present inspection within 6 months to the Dean, College Development Council, University of Kashmir;
17. pay the affiliation fee as prescribed by the affiliating University.
