Subject: Selection of Senior Residents in the department of Physical Medicine and Rehabilitation (PMR), GMC Baramulla.

Pursuant to the recommendations of designated selection committee the following candidates who had applied for the post of senior residents in the department of PMR GMC Baramulla vide **Advertisement NO:- 06 of 2022** dated 27-07-2022 and appeared in the interview which was held on **16-08-2022**, are provisionally selected on academic arrangement basis under SO-364 OF 2020 dated 27-11-2020 in the department of PMR GMC Baramulla for a period of one (01) year which can be extended upto a maximum of three (03) years.

The selections so made shall be governed by **SO-364 OF 2020 dated 27-11-2020**.

The doctors currently working in the department of PMR, GMC Baramulla shall be deemed to be relieved on the day of joining of the selected candidates, due to successful completion of tenure.

However, engagement of the selected doctor shall be subject to the following conditions.

1. That the doctors shall submit their joining report in the office of Principal GMC Baramulla within 07 days from the date of issuance of this selection order.
2. That they shall submit an affidavit duly attested by first class magistrate to the effect that:
 - a. He/she is non-PSC candidate and is not on the rolls of any other institution.
 - b. He/she is not involved in any criminal activity and there is no FIR pending against him in any Criminal Department or Police Station.
 - c. He/she will not indulge in private practice during the tenure. In case he is found doing private practice his appointment shall be terminated without any notice.
 - d. He/she shall not leave the department before the completion of his/her sanctioned tenure.
 - e. He/she will not participate in any kind of strike during the period of his/her tenure as the services are covered under ESMA.
 - f. He/she shall remain disciplined during the tenure period and any kind of misconduct shall make him/her liable for termination without any prior notice.
3. **First month's salary of the candidate shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of their first tenure appointment.**
4. No experience certificate will be issued if he/she leaves without completing his/her sanctioned tenure.
5. That they shall enter an agreement on the prescribed Form A.
6. **They shall submit all the requisite documents in the office of Registrar Academics before joining the departments.**
