The selections so made shall be governed by SO-364 OF 2020 dated 27-11-2020.

However, engagement of the selected doctor shall be subject to the following conditions.

- 1. That the doctors shall submit their joining report in the office of Principal GMC Baramulla within 10 days from the date of issuance of this selection order/ However Dr. Jabeena Bano shall join the department of Obstetrics and Gynaecology GMC Baramulla within 10 days starting from 01-09-2022.
- 2. That they shall submit an affidavit duly attested by first class magistrate to the effect that:
  - a. He/she is non-PSC candidate and is not on the rolls of any other institution.
  - b. He/she is not involved in any criminal activity and there is no FIR pending against him in any Criminal Department or Police Station.
  - c. He/she will not indulge in private practice during the tenure. In case he is found doing private practice his appointment shall be terminated without any notice.
  - d. He/she shall not leave the department before the completion of his/her sanctioned tenure.
  - e. He/she shall remain disciplined during the tenure period and any kind of misconduct shall make him/her libel for termination without any prior notice.
- 3. First month's salary of the candidate shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of their first tenure appointment.
- 4. No experience certificate will be issued if he/she leaves without completing his/her sanctioned tenure.
- 5. That they shall enter an agreement on the prescribed Form A.

6. They shall submit all the requisite documents in the office of Registrar Academics before joining the departments.
