
The appointee shall report in the office of Principal Govt Medical College Baramulla within a period of 21 days along with following original certificates: -

1. Date of Birth Certificate.
2. Qualification certificates.
3. Medical fitness Certificate from CMO concerned
4. Certificate from the concerned Deputy Director, Employment, and general manager, DIC to the effect that no loan under self-employment scheme has been taken by the appointee.
5. Relevant category certificate, where applicable.
6. Any other documents as required under rules.
7. Domicile Certificate of J&K (UT).

The appointment of the candidates shall be subject to the following conditions: -

1. The appointee shall join within the period of twenty-one (21) days from the date of issuance of the appointment order. In case, any appointee failed to join within stipulated period his/her appointment shall be deemed to have cancelled ab-initio without any further notice.
2. Verification/ Genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities.
3. The salary of the appointee shall not be drawn and disbursed to him/her unless the satisfactory report in respect genuineness of (2) above is received. The appointee shall be governed in terms to the Jammu & Kashmir special recruitment Rules 2020 notified vide S.O 194 of 2020 dated 17-06-2020 and Jammu and Kashmir Probationer (Condition of Service, Pay and Allowance) and Fixation of Tenure Rules 2020 notified vide S.O - 192 of 2020 dated 17-06-2020.
4. The appointees shall be governed by the "New Pension Scheme" as notified vide SRO 400 of 2009 dated 24-12-2009.
5. The interim arrangement, if any made against the above post(s) shall be deemed to have been terminated forthwith.
6. The appointment in Divisional cadre is non-transferable from one Division to another or from one Medical College to another.
7. The appointment of the selected candidate(s) shall further be subject to outcome of writ. Petition(s), if any, pending on the subject in any court of competent jurisdiction.
8. The inter-seniority of the above appointees shall be as per the merit secured by his/her in the selection process as indicated against each in the select list furnished by the J&K Services Board.
