- b) Qualification certificate
- c) Domicile certificate
- d) Medical Fitness Certificate from CMO concerned
- e) Certificate from the concerned Deputy Director, Employemnt and General Manager, DIC to the effect that no loan under self employment scheme has been taken by the appointee
- f) Relevant category certificate, wherever applicable.

The Appointment of the candidates shall also be subject to the following conditions.

- 1. The appointee shall join within the period of twenty-one (21) days from the date of issuance of the appointment order. In case, any appointee failed to join within stipulated period his/her appointment shall be deemed to have cancelled ab-initio without any further notice.
- 2. Verification/ genuineness of the qualification certificates and the reserved category certificates from then concerned issuing authorities.
- 3. The salary of the appointee shall not be drawn and disbursed to him/her unless and until the satisfactory report in respect genuineness of (2) above is received. The appointee shall be governed in terms to the Jammu &Kashmir special recruitment Rules 2020 notified vide S.O 194 of 2020 dated 17-06-2020 and Jammu and Kashmir Probationer (Condition of Service, Pay and Allowance) and Fixation of Tenure Rules 2020 notified vide S.O 192 of 2020 dated 17-06-2020.
- 4. The appointees shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24-12-2009.
- 5. The interim arrangement, if any made against the above post(s) shall be deemed to have been terminated forthwith.
- 6. The appointment in Divisional cadre is non-transferable from one Division to another or from one Medical College to another.
- 7. The appointment of the selected candidate(s) shall further be subject to outcome of writ petition(s), if any, pending on the subject in any court of competent jurisdiction.
- 8. The inter-seniority of the above appointees shall be as per the merit secured by his/her in the selection process as indicated against each in the select list furnished by the J&K Services Board.
