In Pursuance to the scheme guidelines issued by the National Drug Dependence Treatment Centre (NDDTC) All India Institute of Medical Sciences (AIIMS) New Delhi, One post of Medical Officer (Addiction Treatment Facility) at GMC Baramulla was Advertised vide Advertisement Notice No. 08 GMCOB of 2022 Dated 13-09-2022 where in application forms were invited from the eligible candidates against the said post for a period of one year extendable on year to year basis subject to good performance and work conduct or till the continuation of central sponsored scheme whichever is earlier. This Office received 14 applications out of which 5 candidates having highest preliminary merit were invited for interview out of which only two candidates whose details are given hereunder attended the interview.

1. Dr. Nighat Khan
2. Dr. Shahnawaz Rashid.

On the basis of highest overall merit achieved, **Dr. Nighat Khan** D/o Siraj-ud-din Khan R/o Peer Bagh Srinagar is hereby selected / engaged as Medical Officer for ATF GMC Baramulla for a period of one year on contractual basis or till the scheme under which the candidate is selected remains in force whichever is earlier on the consolidated pay of Rs. 60000/= per month.

Dr. Shahnawaz Rashid S/o Abdul Rashid Mir R/o Panzgam Kupwara is falling in the waiting list which will be operated within 6 months from the date of issuance of this order.

The selected candidate shall join within the period of 07 days from the issuance of the order.

The selected candidates shall produce the following documents in original to this office at the time of joining.

- a) Date of Birth.
- b).State subject Certificate/Domicile Certificate.
- c) Degree Marks certificate.
- d) Degree certificate.


The appointment of the candidate is subject to the following conditions:-

- a. Salary of the appointee shall not be drawn and disbursed to them unless satisfactory report in respect of below (v) is received in his/her favour.

- b. *The first month salary will be released only after the completion of one year tenure which will remain as security deposit and Experience certificate will be issued only after completion of the tenure.*
- c. *In case the candidate is desirous to leave the job before the completion of the tenure he/she shall have to inform the Concerned HOD at least one month earlier.*
- d. *The Engagement can be terminated on account of non-performance without any notice keeping in view of the public health importance of the program.*
- e. *The engagement is purely on contractual basis for a period of one year.*

The selected candidate shall furnish an undertaking duly signed by 1st class Magistrate in the shape of affidavit to the effect that:-

- i. He/she will adhere to the roster of duties to be issued by the administration.
- ii. He/she will not participate in any kind of strike/protest against the administration during his/her tenure in the College/Hospital.
- iii. If the documents filed by him/her are found wrong/incorrect at any point of time, his/her appointment shall be terminated immediately and disciplinary action and legal proceedings shall be initiated against him/her.
- iv. He/she has not been appointed in any other Govt. /Semi-Govt. department and is not working anywhere at present.
- v. In case adverse report about his/her character and antecedents/ Academic Certificate is received from the CID J&K and concerned quarter, the candidate shall have no right to claim his/her appointment and it shall be deemed to have been cancelled ab-initio.
- vi. This engagement is purely on contractual basis and selected candidate shall not claim for regular appointment.
