

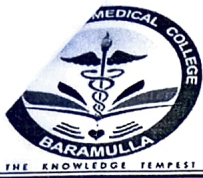
**However, engagement of the selected doctor shall be subject to the following conditions.**
