

1. That the doctors shall submit their joining report in the office of Principal GMC Baramulla within 14 days from the date of issuance of this selection order.
2. That they shall submit an affidavit duly attested by first class magistrate to the effect that:
  - a. He/she is non-PSC candidate and is not on the rolls of any other institution.
  - b. He/she will not indulge in private practice during the tenure. In case he is found doing private practice his appointment shall be terminated without any notice.
  - c. He/she shall not leave the department before the completion of his/her sanctioned tenure.
3. First month's salary of the candidate shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of the tenure appointment at the time of their relieving.
4. No experience certificate will be issued if he/she leaves without completing his/her sanctioned tenure.
