Subject: - Selection of Senior Resident and Medical Officers on Academic Arrangement basis under SO 364 in the Department of Radio-diagnosis and Imaging Government Medical College Baramulla

(ORDER)

Whereas consequent upon a meeting held under the Chairmanship of Principal/Dean, with HOD Radio-diagnosis and Imaging regarding acute shortage of Resident doctors in the department of Radiology and in order to overcome the acute shortage, walk in interviews for selection of Senior Resident and Medical Officers on academic arrangement basis were advertised vide office Notice No GMC/Bla/Acad/2022/2244-2251 dated 29-08-2022.

Whereas a committee comprising of experts of Radiology Department and other members were constituted to conduct the walk-in interviews vide this office order No: GMC/Acad/2252 dated 29-08-2022 for selection of Senior Residents and Medical Officers in Radio-diagnosis & Imaging Department.

Whereas the Selection Committee met on 30-08-2022 under the chairmanship of worthy Principal/Dean and on the recommendations of the committee, the following doctors were selected temporarily in the interest of patient care and for smooth functioning of the Radio-diagnosis and Imaging Department :-

1. **Dr.Abid Ali Senior Resident** Radio-diagnosis & Imaging Department for a period of 01 year or till proper advertisement of Senior Residents in GMC Baramulla is advertised by this college.
2. **Dr.Qayoom Jan, Medical Officer** (on academic arrangement basis)
3. **Dr.Kumail Hussain Mir, Medical Officer** (on academic arrangement basis)
Sr.No: 2 and 3 were selected as Medical Officers on academic arrangement basis in view of their experience in Radiology Department and on the basis of performance in walk in interviews. Their selection as Medical Officers is hereby made in order to provide additional experienced manpower to the department for smooth functioning of emergency and routine services. However, their selection is subject to further confirmation from the Administrative Department. Their engagement shall remain for a period of 06 months or till the selection of Medical Officers is made by the J&K Public Service Commission whichever is earlier.

However, engagement of the selected doctor shall be subject to the following conditions.

1. That they shall submit his/her joining report in the office of Principal GMC Baramulla within 07 days from the date of issuance of this selection order.
2. That they shall submit an affidavit duly attested by first class Magistrate to the effect that:
 - a. He/she is non-PSC candidate and is not on the rolls of any other institution.
 - b. He/she is not involved in any criminal activity and there is no FIR pending against him in any Criminal Department or Police Station.
 - c. He/she will not indulge in private practice during the tenure. In case He/she is found doing private practice his/her appointment shall be terminated without any notice.
 - d. He/she shall not leave the department before the completion of his/her sanctioned tenure.

- e. He/she will not participate in any kind of strike during the period of his/her tenure as the services are covered under ESMA.
- f. He/she shall remain disciplined during the tenure period and any kind of misconduct shall make him/her liable for termination without any prior notice.
3. First month's salary of the candidates shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of the tenure appointment at the time of their relieving from the department.
4. No experience certificate will be issued if they leave without completing their sanctioned tenure.
5. That they shall enter an agreement on the prescribed Form A.
